



## PRIVACY POLICY

This Privacy Policy sets out the commitment of AgCommunicators Pty Ltd (ABN 78 166 935 020), its successors and assignees (referred to as **we**, **us** and **our**) to protecting the privacy of your personal information in accordance with the *Privacy Act 1988* (Cth) (**Privacy Act**) and the Australian Privacy Principles (**APPs**). This Privacy Policy sets out the personal information we collect through this website [www.agcommunicators.com.au](http://www.agcommunicators.com.au) (**Site**) or directly from you, being the person, organisation or entity that uses our Site or services (referred to as **you** or **your**).

Please read this Privacy Policy carefully. Please contact us if you have any questions – our contact details are at the end of this Privacy Policy.

You providing us with personal information indicates that you have had sufficient opportunity to access this Privacy Policy and that you have read and accepted it.

If you do not wish to provide personal information to us, then you do not have to do so, however it may affect your use of this Site or any products and services offered on it.

### Collection of personal information

**Personal information:** The type of information we collect may include:

- name;
- photographs;
- contact details including email address, address and telephone number;
- demographic information (including postcode and rainfall area);
- areas of interest;
- age or age bracket where applicable;
- preferences and opinions; and
- any other information requested on this Site or otherwise requested by us or provided by you.

**Your use of our Site:** As with most online businesses, we may log information about your access and use of our Site, including through the use of Internet cookies, your communications with our Site, the type of browser you are using, the type of operating system you are using and the domain name of your Internet service provider.

**Your opinion and feedback:** We may contact you to voluntarily respond to questionnaires, surveys or market research to seek your opinion and feedback. Providing this information is optional to you.

If we receive your personal information from third parties, we will protect it as set out in this Privacy Policy.

## Collection and use of personal information

We collect and use the information for purposes including:

- to provide our services as set out on the Site or otherwise notified to you;
- to contact and communicate with you;
- for record keeping;
- for market research and business development including website development;
- for marketing including direct marketing;
- to send you promotional information about third parties that we think may be of interest to you; and
- for data analytics purposes.

## Disclosure of personal information to third parties

We may disclose personal information to:

- our clients in accordance with our provision of services;
- credit reporting agencies and courts, tribunals and regulatory authorities where customers fail to pay for goods or services provided by us to them;
- courts, tribunals, regulatory authorities and law enforcement officers as required by law, in connection with any actual or prospective legal proceedings, or in order to establish, exercise or defend our legal rights;
- third parties, including agents or sub-contractors, who assist us in conducting market research or providing information, products, services or direct marketing to you. This may include parties located, or that store data, outside of Australia; and
- third parties to collect and process data including Google Analytics. This may include parties that store data outside of Australia.

Where we disclose your personal information to third parties for these purposes, we will request that the third party follow this Privacy Policy regarding handling of your personal information. Please note third party privacy policy may apply.

If there is a change of control of our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible by law our user databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser. We would seek to only disclose information in good faith.

## How we treat personal information that is also sensitive information

Sensitive information is a sub-set of personal information defined under the Privacy Act and is given a higher level of protection under the APPs. In referring to 'sensitive information' we mean information that relates to your racial or ethnic origin, political opinions, religion, trade union or other professional associations or memberships, philosophical beliefs, sexual orientation or practices and criminal records, health information or biometric information.

The type of sensitive information that we may collect includes your health information such as any allergies or dietary requirements.

Sensitive information will be used and disclosed for purposes relating to the primary purpose for which the sensitive information was collected, including:

- to manage catering needs; and
- providing the relevant services in accordance with your request.

Sensitive information may also be used or disclosed if:

- required or authorised by law; or

- to a responsible person which has the meaning given by section 6AA of the Privacy Act 1988.

## Your rights and controlling your personal information

**Choice and consent:** Providing us with your personal information is optional to you. You can choose not to provide personal information. When you provide us with your personal information, you consent to the terms in this Privacy Policy, and to us disclosing or receiving your personal information for these purposes.

**Your provision of third party information:** If you provide us with third party personal information then you warrant to us that you have the third party's consent to provide this.

**Restrict:** You may choose to restrict the collection or use of your personal information. If you have previously agreed to us using your personal information for direct marketing purposes, you may change your mind at any time by contacting us at the email address listed in this Privacy Policy.

**Access:** You may request details of personal information that we hold about you, in certain circumstances set out in the Privacy Act. An administrative fee may be payable for the provision of information. We may refuse to provide you with information that we hold about you, in certain circumstances set out in the Privacy Act.

**Correction:** If you believe that any information we hold about you is inaccurate, out of date, incomplete, irrelevant or misleading, please contact us by email. We rely in part upon customers advising us when their personal information changes. We will respond to any request within a reasonable time. We will endeavour to promptly correct any information found to be inaccurate, incomplete or out of date.

**Complaints:** If you believe that we have breached the Privacy Act or APPs and wish to make a complaint about that breach, please contact us by email setting out details of the breach. We will promptly investigate your complaint and respond to you in writing setting out the outcome of our investigation, what steps we propose to take to remedy the breach and any other action we will take to deal with your complaint.

## Cookies & Web Beacons

We may use web beacons on this Site from time to time. Web beacons or clear .gifs are small pieces of code placed on a web page to monitor the visitors' behaviour and collect data about the visitors viewing a web page.
